# **CORPORATION OF THE TOWNSHIP OF FAUQUIER-STRICKLAND**

#### BY-LAW 2019-23

BEING A BY-LAW TO APPOINT A COMMUNITY EMERGENCY MANAGEMENT COORDINATOR (CEMC) AND ALTERNATES, AND AN EMERGENCY INFORMATION OFFICER (EIO) FOR THE MUNICIPALITY

**WHEREAS** the Emergency Management and Civil Protection Act, RSO 1990, Chapter E.9, subsection 2.1(1) requires that every municipality develop and implement an emergency program;

**AND WHEREAS**, subsection 10(1) of Ontario Regulation 380/04 under the Emergency Management and Civil Protection Act requires that every municipality shall designate an employee of the municipality, or a member of council as its emergency management program coordinator;

**AND WHEREAS** subsection 14(1) of Ontario Regulation 380/04 under the Emergency Management and Civil Protection Act requires that every municipality shall designate an employee of the municipality as its emergency information officer;

**AND WHEREAS** under Section 20(1) of the Municipal Act 2001, as amended from time to time, a municipality may enter into an agreement with one or more municipalities to jointly provide for their joint benefit, any matters which all of them have the power to provide within their own boundaries.

**NOW THEREFORE**, Council of the Corporation of the Township of Fauquier-Strickland, enacts as follows:

#### 1. CEMC APPOINTMENT

Rémi Desbiens, Community Emergency Management Coordinator for the Town of Smooth Rock Falls is hereby designated Community Emergency Management Coordinator for the Township of Fauquier-Strickland. For the purposes of this appointment, Rémi Desbiens shall be deemed an employee of the Township of Fauquier-Strickland while carrying out his duties.

### 2. ALTERNATE CEMC APPOINTMENTS

## 2.1 First Alternate CEMC

Nathalie Vachon is hereby designated as first alternate Community Emergency Management Coordinator for the Township of Fauquier-Strickland.

## 2.2 Second Alternate CEMC

Jacques Demers is hereby designated as second alternate Community Emergency Management Coordinator for the Township of Fauquier-Strickland.

### 3. <u>EIO APPOINTMENT</u>

Tracy Gagnon is hereby designated as Emergency Information Officer for the Township of Fauquier-Strickland, who shall be the primary media and public contact for the municipality in an emergency.

### 4. **DUTIES**

The duties of the Community Emergency Management Coordinator and the Emergency Information Officer shall be those prescribed by the Emergency Management and Civil Protection Act and the regulations made thereunder.

#### 5. **SEVERABILITY**

If any part of this By-law is, for any reason, held to be invalid by the decision of a Court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this By-law.

# 6. SHORT TITLE

This By-law may be referred to or cited as the "CEMC" appointment By-law.

### 7. EFFECTIVE DATE AND REPEALS

This By-law comes into force on the day it is passed; and upon the passing of this By-law any other By-law or By-laws appointing a Community Emergency Management Coordinator or Alternate(s) or an Emergency Information Officer is (are) hereby repealed.
